A franchise disclosure document is a legal document which is presented to prospective buyers of franchises in the pre-sale disclosure process in the United States. It was originally known as the Uniform Franchise Offering Circular, prior to revisions made by the Federal Trade Commission in July 2007. Franchisors were given until July 1, 2008 to comply with the changes. The Federal Trade Commission Rule of 1979 which governs the disclosure of essential information in the sale of franchises to the
